<u>Letter requesting from the US</u> Pension office, information on Michael and Peter <u>Fulp.</u>

Dear Madam Reference is made to your request for the records of Michael and Peter Fulp and Nicholas and Peter Michel, soldiers in the Revolution.

Revolutionary War data furnished by this office are obtained from claims made to the United States for pension and bounty land based upon the military service of soldiers in that war. A careful search of the records fails to show such claims on file on account of the service of Nicholas or Peter Michael, searched under all spelling of this name.

The data which follow were obtained from papers on file in pension claim # 10043 based upon the military service of Michael Fulp.

He was born in April 1755 in Lancaster County, Penn. The names of his parents were not given.

WHILE LIVING in Surry County NC he enlisted and served as private with the NC troops as follows: In 1776, four months in Capt. William Hobson's Company in Col. Joseph Williams Regiment on an expedition against the Cherokee Indians; from July 1781, three months in Capt. David Humphreys Company in Col. James Martins Regiment, also served two weeks, names of officers not given. He enlisted in guarding prisoners.

He was allowed pension on his application executed March 15, 1833at which time he was living in Stokes Co., which was formerly a part of Surry Co. NC.

Michale Fulp died May 7, 1836. This soldier married near "Townfork" in Surry Co NC Aug 20, 1777to Phebe Scott who was born Oct. 24, 1758.

As the widow of Michael Fulp, she was allowed pension on her application executed Dec. 13, 1838, at which time she was living in Stokes Co NC

The data which follow were obtained from papers on file in the pension claim # 278 based upon the military service of Peter Fulp.

He was born in May 1761, place of birth or names of parents not given.

WHILE LIVING in Surry Co NC he enlisted and served as private with the NC troops as follows: from Jan, Feb or Mar 1776, 2months in Capt. Richard Goode's Company in Col. Joseph ------ Regiment; from sometime in the summer of 1776, for months in Capt. Goode's company in Col. Williams Regiment on an expedition against the Cherokee Indians; next served three months under Capt.

Shepperd and was in the battle of Kings Mountain; in 1781, three months in Captain ----- Smiths Company in Col. James Martins Regiment and was discharged soon after the surrender of Cornwallis at Yorktown.

He died June 1814. His widow, Elizabeth was allowed pension on her application executed June 13, 1839at which time she was seventy eight years of age and was living in Stokes Co NC.

It was stated that Michael Fulp was the brother of the soldier Peter Fulp.
